Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The Tom Green County Auditor certifies that Tom Green County has spent \$842,224 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. The Tom Geen County Sheriff has provided Tom Green County information on these costs, minus the state revenues received for the reimbursement of such costs. This increased the voter-approval tax rate by \$0.00298/\$100.
